PLEASE READ AND INITIAL AFTER EACH ITEM

THIS AGREEMENT is entered into by and between Bark n' Bath | Alice Springs, and the pet(s) OWNER:

- 1)** I (Owner) represent that I am the legal owner of the above-named pet(s) and I assume all risks, dangers, and responsibility for injuries to the named pet(s). Owner understands and agrees that Owner is solely responsible for any harm while Owner's pet(s) is/are attending Grooming, Daycare and/or Boarding.
INITIAL:
- 2)** PHOTO AND VIDEO RELEASE: We love to post pictures and videos on Facebook, our website, and/or in magazine ads. Owner agrees to allow bark n bath to use Owner's pet's name and any images or likeness of Owner's pet taken while he/she is at Bark n' Bath in any form, for use at any time, in any media, marketing, advertising, illustration, trade or promotional materials without compensation, and Owner releases to Bark n' Bath all rights that Owner may possess or claim to such image, likeness, recording, etc.
INITIAL:
- 3)** PET'S HEALTH: Owner further understands and agrees that Owner's pet(s) are healthy and are not enrolling any pet that has any condition that could potentially jeopardise the health of other pets or people and has not had any potentially communicable condition within 30 days prior to enrolment. Owner further understands that even if Owner(s) pet is vaccinated for Bordetella (Kennel Cough) there is a chance that the Owner's pet can still contract Kennel Cough. Owner agrees that Owner will not hold Bark n' Bath responsible if Owner's pet(s) contracts Kennel Cough or other pet to pet transmitted ailments.
INITIAL:
- 4)** FLEA/TICK FREE: All pets must be flea/tick free. Should a pet be observed to have fleas or ticks, a flea/tick bath treatment will be applied and charged to the owner at a rate of up to \$80 depending on severity and size of pet.
INITIAL:
- 5)** GROUP PLAY: All dogs must pass a general behaviour assessment in order to attend dog-dog group play. No dog may be admitted to group play who shows any signs of any type of aggression. Owner further understands and agrees that in admitting Owner's dog(s) to dog-dog group play, Owner is representing to Bark n' Bath that Owner's dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behaviours towards any person or other dogs. Any dog demonstrating aggression or other behaviour deemed unacceptable by Bark n' Bath staff may be required to leave day-care/boarding.
INITIAL:
- 6)** RELEASE OF LIABILITY: Owner understands and agrees that during normal dog play, Owner's dog may sustain injuries. Dog play is monitored by Bark n' Bath staff to best avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Owner further understands and agrees that neither day-care/boarding nor any of its employees, staff, or volunteers will be liable for any illness, injury, death, and/or escape of Owner's dog(s) provided that reasonable care and precautions are followed, and Owner hereby Release Bark n' Bath staff or volunteers of any liability of any kind whatsoever arising from or as a result of Owner's dog(s) attending Bark n' Bath.
INITIAL:
- 7)** PERSONAL PROPERTY: Owner understands that Owner is solely responsible for any harm, including to any other pet(s), to the employees or invitees of Bark n' Bath, or to the equipment, facilities, or other property of Bark n' Bath, caused by Owner's pet(s). Owner also agrees that Bark n' Bath shall not be responsible or liable for any lost or damaged personal property belonging either to Owner or Owner's pet.
INITIAL:
- 8)** MEDICATION: When boarding overnight, Owner agrees that it is the Owner's responsibility to leave adequate supply of medications for Owner's PET(s) during the entire time Owner's PET is cared for by Bark n' Bath. Should the medication supply need replacement, Owner authorises Bark n' Bath to purchase replacement and Owner will reimburse Bark n' Bath for the actual medication costs.
INITIAL:



- 9) **WEAKENED IMMUNE SYSTEM:** Owner understands special-needs pets, young pets, and senior pets naturally have a higher risk of injury, stress-related illnesses, weakened immune system, or exacerbation of any pre-existing condition. As such, by using our facility for day-care or boarding the Owner is waiving any claim for injury or illness experienced by Owner's pet(s) while in our care.
INITIAL:
- 10) **ELDERLY DOGS:** Owners of elderly dogs (approaching the end of life) need to know if in the event Owner's dog passes on while in our care, our policy is to transport Owner's dog to Owner's vet where he/she will be held until Owner can be reached by the Vet for further instructions. If Owner's vet is closed then we will transport to nearest 24-hour facility.
INITIAL:
- 11) **PAYMENTS:** For daycare and grooming payments are due and payable at the end of each visit or as discussed with management. Boarding payments are due in full on drop off or as discussed with management.
INITIAL:
- 12) **CANCELLATION / NO-SHOW POLICY:** Cancellations must be done 24-hours prior to reservation date. If cancellation notice is less than 24-hours an amount of 50% of total fee will be charged at managements discretion.
INITIAL:
- 13) **CLOSING TIME:** Owner agrees that if Owner's pet(s) is/are not picked up by closing time then Owner hereby agrees to an overtime fee of \$15 per 15min or part thereof. If owner is not contactable after 30 minutes from closing time then owner hereby agrees that pet(s) will be put in boarding for the night and charged at full boarding rates.
INITIAL:
- 14) **RIGHT OF REFUSAL:** Bark n' Bath reserves the right to refuse admittance to any pet or dismiss any pet that does not meet or maintain the health, temperament or other daycare/boarding standards. The determination shall be made at the sole discretion of Bark n' Bath.
INITIAL:
- 15) **BARKING:** Owner understands that excessive barking may result in the use of a static correction collar / barking collar. This determination shall be made at the sole discretion of Bark n' Bath Staff and will only be used as a last resort. **If NO: Owner agrees to collect dog(s) immediately if excessive barking ensures. If owner is unable to collect, alternate contact will be contacted.**
INITIAL:
- 16) **VETERINARIAN LIABILITY AND CARE:** Owner agrees to Bark n' Bath to obtain medical treatment for Owner's pet(s) if he/she appears ill, injured or exhibits any other behaviour that would reasonably suggest that pet(s) may need medical treatment including anaesthesia. Owner agrees to be fully responsible for the cost of any such medical treatment and for the cost of any transportation for the purposes of such treatment. Owner gives permission to Bark n' Bath to use Owner's vet or nearest 24-hour vet hospital for required treatment.
INITIAL:
- 17) **FULL FORCE AND EFFECT:** Owner further understands and expressly agrees that each and every one of the foregoing provisions contained in paragraphs 1-17 shall be in force and effect and shall apply to each and every occasion on which Owner's pet(s) stays with Bark n' Bath for daycare, extended boarding, grooming or as the case may be. This Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superseded by a writing signed by the parties. Owner hereby certifies that Owner has read and understands this Waiver and Release of Liability and the regulations set forth above. By signing this agreement, Owner agrees to be bound by its terms and conditions.
